## Who can join?

To be eligible for ArchCare Community Life, you must meet all of the following requirements:

- You must be 21 years of age or older
- You receive or are eligible for Medicaid
- You need more than 120 days of community-based long-term-care services
- You are able to live safely in the community at the time you enroll
- You reside in ArchCare Community Life's service area, which currently includes Manhattan, The Bronx, Brooklyn, Queens, Staten Island, Westchester and Putnam County
- Nursing Assessment will be performed to determine eligibility

## How much does it cost?

How much you pay for ArchCare Community Life depends upon your eligibility for Medicare and Medicaid.

If you are eligible for Medicare and Medicaid or eligible for Medicaid only and do not have a spend-down,\* there is no cost to you for Community Life-covered services.

If you live in the New York City service area, your spend-down is determined by the New York City Human Resource Administration (HRA).

If you live in Westchester or Putnam counties, your spend-down is determined by the Local Department of Social Services (LDSS).

Also, there is no additional cost to you for authorized covered services in the Community Life provider network. However, if you choose to access services on your own that are not covered or obtain services of a nonparticipating provider that are not authorized by Community Life, you may be subject to payment of these services.

\*Spend-down, which is also known as surplus, is the difference between your monthly income and the monthly Medicaid rate.
